
Since January 2020, after completion of the GTSO **unbundling**, Ukrtransgaz has started to operate as an independent Storage System Operator of Ukraine.


ACCESS TO THE STORAGE FACILITIES



Access to storage services (injection, withdrawal) of natural gas shall be done on the basis of a gas storage (injection, withdrawal) agreement, standard form of which is approved by the Regulator.

Main regulations: the law «On the natural gas market», Gas Storage Facilities Code, Gas Transmission System Code, agreement on natural gas storage (injection, withdrawal)


HOW TO BOOK GAS STORAGE SERVICES?



CAPACITY ALLOCATION



ALL LOCATION OF FREE UGS CAPACITY



- Annual capacity, 90%: submission: Feb.01 - Feb.15 approval/refusal: until 1 March injection and withdrawal curves
- Individual monthly services, 10%: submission: not later than 10th day of the current month for the following month(s) approval/refusal: not later than 14th day of current month

CORE ALLOCATION PRINCIPLES:

- free gas storage capacity for a certain period is calculated considering the current storage level of UGS and terms stipulated in the valid storage agreement
- option of simultaneously use the annual capacity and individual services for customers
- allocation of free gas storage capacity shall be in the following merit order: annual capacity, individual monthly services, and individual day-ahead services.


Capacity allocation is regulated by the chapter VII of the Gas Storage Facilities Code

The Storage System Operator adheres to the principles of openness and transparency to ensure effective operation of the storage business in Ukraine

COST+ TARIFF METHODOLOGY

Fixed price, no auction procedures

Tariffs for gas storage services in Ukrainian UGS are more favorable compared to tariffs in European gas storages
