





Submitters background




1. Overall, are you satisfied with ERRA RE COM work in past two years?




2. Comments, if any:

3. RE COM agendas and materials help me to improve my own knowledge on regulatory topics and international practice.




4. RE COM agendas and materials have impact on regulatory duties/ projects/ decisions and help improving regulation in the country.




5. Please briefly describe an example of concrete impact, if any.

6. Have you been satisfied with online meeting operation?




7. Have you been satisfied with hybrid meeting operation?

- Hybrid operation is the best option for me because of the potential time savings given the ability to connect online.


9. What is your preferred meeting format in the future?
