



Submitters background




1. Overall, are you satisfied with ERRA EMER COM work in past two years?




2. Comments, if any:

3. EMER COM agendas and materials help me to improve my own knowledge on regulatory topics and international practice.




4. EMER COM agendas and materials have impact on regulatory duties/ projects/ decisions and help improving regulation in the country.




5. Please briefly describe an example of concrete impact, if any.

- Latest energy rise topic and external speaker and slides help to "forecast" better new EU Regulation (Cambridge and Oxford as influencer e.g. on EU Regulation)
- It cannot be said that we have actually taken over and implemented something concrete on the basis of materials and documentation within this working group in the past period. However, we have gained some experience in, for example, prosumers and energy communities that represent entities that have not yet been introduced into the legal framework in BiH and these experiences may be useful in the future when introducing these new participants in the electricity market.
- Impact is in terms of additional information.
- There was an inquiry about how to deal with the R&D cost of the service providers, and the replies were beneficial.

6. Have you been satisfied with online meeting operation?




7. Have you been satisfied with hybrid meeting operation?

- I think online and hybrid meetings have increased the opportunity for the experience exchange and meeting the professional members.


9. What is your preferred meeting format in the future?
