Regulation of Energy Storage – Online Training



During the 3-week online training, the participants will gradually learn how to effectively foster deployment of energy storage in the power system via various regulatory tools.

The course will:

- describe the purposes and current dynamics in energy storage,
- allow to assess whether or not a regulatory framework is fit for energy storage,
- guide on how to modify/structure market design and grid regulations in a way that supports energy storage.

Regulation of Energy Storage – Online Training



The course is dedicated to the core responsibilities and activities of water utility regulatory authorities.

Participants will gain knowledge on:

- general challenges of water management,
- **key economic concepts** guiding the operation of the sector,
- the role of the regulator and regulatory models including best practices, tariff setting and approval,
- role of performance benchmarking in regulation.

Theoretical lessons will be supplemented by case study examples and a tariff setting exercise.
