Energy Transition Task Force (ETTF)



The ETTF is established and will have a 2-year mandate.

The Team consists of minimum of 5 ERRA member regulators and coordinated and managed by the ERRA Energy Transition Expert.

General Purpose:

- \checkmark Map the practices of regulators on energy transition.
- Provide analyses of innovative approaches towards regulation of novel, low- or no-emission energy sources and solutions.
- ✓ Create an energy transition platform/hub/knowledge center.
- ✓ Follow international trends via independent research and keeping the ERRA community informed.
- ✓ Facilitate bilateral or multilateral information exchange on subject matter among members.
- ✓ Assist other ERRA working groups and committees in their energy transition related workstreams.
- Cooperate with international frameworks/cooperatives aiming at energy transition facilitation including, but not limited to, the Regulatory Energy Transition Accelerator (RETA).
