

The Structure of Natural Gas Market in Georgia



- The physical delivery of natural gas to final consumers is ensured by the natural gas transportation licensees and distribution licensees.
- Based on the latest data from 2024, 19 licensees were operating in the natural gas sector, comprising one in transportation and 18 in distribution
- Among them are three large licensees ("Tbilisi Energy" LLC, "Socar Georgia Gas" LLC, "SakOrgGas" JSC). These three major distribution licensees accounted for 90% of the total distributed gas
- Based on the tariff methodology, all distribution licensees have different tariffs, which are based on their own costs.
- Customers on different sides of the street often have different tariffs, which is confusing to them and often causes dissatisfaction among customers.




Tariff regulatory framework and number of DSO's




- Natural gas transportation and distribution activities, as natural monopoly activities, are fully subject to the Commission's tariff regulation.
- As for natural gas supply, according to Order N69 of September 25, 2007, of the Minister of Energy of Georgia on Deregulation and Partial Deregulation of Natural Gas Supply Activities, The supply tariffs for non-household consumers are deregulated, and natural gas is supplied without the Commission determining the tariff.
- This supply occurs under the conditions and at prices publicly offered by the supplying enterprise
- The supply tariffs for household consumers are regulated by GNERC and the tariffs are set for the 2022-2026 tariff regulation period.

Dynamics of the Number of Natural Gas Distribution Licensees




The Structure of Natural Gas Consumption Tariff
