

#### **ERRA SURVEY – INTRODUCTION**

- A key deliverable of the ERRA 5 year strategy
- Goal to better understand member's needs and create common ground for future strategic adjustments
- Questionnaire design and evaluation carried out by Secretariat.
- Questionnaires by multiple type of respondents
  - Decision-Makers (23 respondents)
  - Liaison Officers (23 respondents)
  - Committee Members
- 49% response rate by decision makers and liaison officers,
   29% among committee members


**Message**: ERRA is seen as a «regulatory club» to meet regularly and learn from each other. Training and benchmarking research are expected as well as tools for capacity building.




#### The frequency of ERRA committee meetings is:




#### The intensity of work in-between the meetings is:


## What is your overall evaluation of the Committee you are member of?




# MEDIUM VISIBILITY OF DELIVERABLES AND LOW ENGAGEMENT IN DRAFTING



Do you have an opinion on the ERRA Research and Publications?





Have you ever attended the ERRA Annual Conference or the ERRA Energy Investment and Regulation Conference?










Have you ever interacted with ERRA Secretariat?




If yes, how do you assess the work of the ERRA Secretariat overall?






Top score (10): 2023/ CP COM/ New Phenomena in the Energy Markets in ERRA Member Countries (benchmarking)








Would your organization be willing to take part in compiling or co-authoring a report in the future?



Overall grade for Committee publications and research




Overall grade for consultant-based ERRA publications and research


